

IRMSL Men's Summer Tennis League
May to August 2022
Organizational Format (3 Court/Position League)

1. Play by USTA Rules and Friend at Court **unless existing league rules are in place to specify otherwise.**
2. Appropriate tennis attire required at ALL clubs
3. **Six (6) teams in the league - 2022**

Buttonwood	North River Shores	Mariner Sands
Jupiter travel team	Summerfield	Willoughby
4. Play **Thursday** mornings with team management/schedules/scoring via IRMSLtennis.topdoglive.com.
 - NO guest fees will be charged to the visiting team
 - Team Jupiter will always travel to the other teams.
 - Team Jupiter will be designated the "home" team AND provide the tennis balls for those matches.
 - **Scores should be entered by 8m on match day**
 - **Either captain can enter the scores**
5. Each team needs a minimum roster of six (6) players
 - Minimum age is 45 years old
 - Skill/ability level 3.0 to 4.0 ONLY – no 4.5's
 - Women ARE permitted to be rostered
 - Players can be added to the roster as needed by contacting Jessica
 - Players must be added to the team roster before they can play in a match
6. Rostered players SHOULD BE a member of the participating club.
 - If a non-member is requested, contact Jessica. She will research the player and upon approval will add him/her to your roster.
 - **Players must physically play in at least two (2) matches to be eligible to play in any playoff matches.**
7. Three (3) courts/positions of doubles will be played per match.
 - One (1) point per court/position will be awarded to winning team with three (3) points max per match.
 - An optional 4th court CAN be played IF both captains agree but NO POINTS will be awarded.
 - Captains to advise opponents at least 24 hours in advance of any defaults
8. Play traditional best 2 out of 3 sets with a super tiebreak (1st to 10 by 2 points) in lieu of playing a full 3rd set.
 - **If all 4 players agree to play a full 3rd set PRIOR to play beginning, a full 3rd set may be played.**
 - A regular tiebreak to determine winner of 1st or 2nd set (1st to 7 by 2 points).
 - ALL tiebreaks will follow the [Coman Procedure](#).
9. Play strongest player (court/position #1) to weakest (court/position#3).
 - 4.0 players may not play on court/position #3
 - Maximum court combined ratings – (only three (3) 4.0's can play per match)
 - Court/position #1 – 8.0
 - Court/position #2 – 7.5
 - Court/position #3 – 7.0 (NO 4.0 players permitted here)
10. 2022 league season will run –
 - May 5th to July 7th - regular scheduled play
 - Ten (10) regular matches will be scheduled with two (2) additional weeks for playoffs
 - **Week of Thursday July 14th will be used for rain makeups**
 - If not needed, Playoff #1 will play on July 14th & Playoff #2 will play on July 28th
 - **ALL** regular scheduled match scores must be reported/entered prior to any playoff matches

- July 28th Playoff #1 - teams determined by final placement after regular play completed.
 - Teams 1-4 will play with play located at the higher ranked team's club
- August 4th Playoff #2/Finals – all four (4) playoff teams will play
 - Play located at the higher ranked team's club
